What is a SHAREholder?

A SHARE Charlotte nonprofit partner who has joined SHARE SHINE™.

Why should I become a SHAREholder?

SHARE SHINE™ is the premiere professional development hub for SHARE Charlotte nonprofit partners, offering affordable networking and educational opportunities for nonprofits regardless of size or budget.

How do I sign up to become a SHAREholder?

How much does SHARE SHINE™ cost?

2025 SHARE SHINE™ is \$275 for 12 months. Your annual renewal is due on the anniversary of your initial registration. Professional Development Workshops are an additional fee.

What is included in SHARE SHINE™?

- SHARE SHINE™ includes:
 - SHARE-a-Latte invitations for your entire team. ([Nine scheduled in 2025](#))
 - SHARE-a-Latte (SAL) is SHARE Charlotte's monthly networking coffee that offers an intentional opportunity for Charlotte nonprofits to come together to hear from community leaders, funders, influencers and innovators - exposing SHARE's nonprofit partners to new ideas while building social capital. SAL is always hosted in a different Charlotte location to expose our partners to venues and neighborhoods they may otherwise not have the opportunity to explore.
- Complimentary postings on the Do Good Work Job Board.
- First access to the Annual SHARE Charlotte Nonprofit Summit for an additional fee.
- Access to a comprehensive list of 70+ local funders including contact information and their funding priorities.

How do I post a job on the Do Good Job Board?

How much do SHARE SHINE™ Professional Development Workshops cost?

Professional Development Workshops are available to SHAREholders and are an additional cost for each staff member.

- Fundraising Series (6 monthly sessions January through June): \$450
 - Fundraising kick-off on January 30 (Track 101) and January 31 (Track 201) open to additional staff who will be attending the series for \$50 each
- Board Development & Engagement Series (3 monthly sessions July-September): \$250
- Board Chair & Executive Director Partnership: \$150 (*includes both ED & Board Chair as both are required to attend*)
- Power of Story: \$150

In 2024, we divided SHARE Charlotte's Professional Development Workshops into two tracks to tailor training to different sized organizations. The feedback from attendees has been overwhelmingly positive, so we will continue to offer this custom experience.
